AI Joan: contact Pat Harris to prepare documentation for registration of ANSI/NISO Z39.47. TC46 standards need to be registered. NISO can do that as the secretariat of TC46 for the ISO standards.

AI Joan and Rick: publish mapping tables for TC46 standards.

### **10.6. COBOL – response to J4 and SC22/WG4**

The recommendation of L2 is that the Unicode standard be used and not 14652.

AI Moore: Lisa will reply to Klein and recommend that Unicode be used instead of TR 14652 for COBOL.
