The IRG#20 was attended by China, D.P.R.Korea, HKSAR, Japan, Macao SAR, R.O.Korea, Singapore, TCA, USA, Vietnam, and Unicode (Liaison member) and have made the following resolutions:

Resolution IRG M20.1: Future meeting schedule

Unanimous

The IRG resolves to adopt the following meeting schedule:

- IRG #21 Beijing (needs to be confirmed), China, 2003.04.07-11
- IRG #22 Place to be determined, in October 2003
- IRG #23 Taipei (tentative) and Unicode Consortium will be the backup, in 2004
- IRG #24 R.O.Korea in 2004

Resolution IRG M20.2: Basic Subset of CJK Unified Ideographs (ref: N934, N935, N947)

Unanimous

The IRG accepts the contributions from Japan (N934) and a joint proposal (N935) on the basic subset of CJK Unified Ideographs. An Ad Hoc group was set up and document (N947) was produced to address the need, scope, criteria and submission schedule of the basic subset of CJK Unified Ideographs.

Other than D.P.R.Korea, who needs time to review N947 before WG2 #43, the rest of the IRG members accepts N947. The IRG further instructs the Rapporteur to submit N947 to WG2 and seek formal instructions from WG2.

Resolution IRG M20.3: Clarification of Unification Rules (ref. N941, N949, N951, N953, N955)

Unanimous

The IRG accepts the contribution from Japan (N941) and comments from other member bodies (N949, N951, N953). The IRG resolves to accept the conclusion on this issue in the Ad Hoc group minutes N953, which has a dedicated document N955.

Resolution IRG M20.4: CJK Ext C1 Editorial Group Report (ref.: N928, N952)

Unanimous

The IRG accepts the contributions from N928 and other review reports from editors. The IRG resolves to accept the editorial report N952 on CJK Ext. C1 editorial work review methods, procedure, and schedule. Major milestones are listed as follows:

Resolution IRG M20.5: Member's Chief Editors for CJK Ext. C1

Unanimous

The IRG resolves that each member must have an appointed Chief Editor who will not only be the contact person to channel questions to its member bodies, but also responsible for the quality of its own submission and make sure that the submission complies with IRG regulations and rules. The notification of the appointment for each member body should reach the Rapporteur by 2002.12.16.

Resolution IRG M20.6: Nomination of Rapporteur

Unanimous

Resolution IRG M20.7: Appointments of the IRG Chief Editor and the Technical Editor

Unanimous

The IRG resolves to fix the terms of appointments for the IRG Chief Editor and the Technical Editor. The term of appointment should be the same as that of the Rapporteur. IRG resolves to appoint Mr. Chen Zhuang as the next IRG Chief Editor and Ms. Wang Xiaoming as the next IRG Technical Editor.

Resolution IRG M20.8: First Stroke and Stroke Count (Ref. N942, N954, N954A)

Unanimous

Based on the contribution from Macao (N942), the IRG Ad Hoc group has produced the document N954 and N954A. The IRG resolves to accept N954 and N954A and instructs its editors to follow guidelines stated in the documents.

Resolution IRG M20.9: IRG Radical Classification for Editorial Purpose (Ref. N947, N955)

Unanimous

The IRG recognizes the need for an IRG radical classification to facilitate the editorial work of CJK Ext. C1 and the issue was discussed in the Ad Hoc group(N947). The IRG resolves to accept the proposal for such Radical Classification method in N955. Mr. John Jenkins and Dr. Lu Qin will provide the initial draft for the IRG radical classification data of Ext. B. and CJK in BMP. Unicode will provide a consolidated list.

Resolution IRG M20.10: Explanatory Notes for Annex S of ISO 10646 for IRG Work (Ref. N951)
