JTC 1 Matters:

RESOLUTION M14-01: ARO of the Unicode Consortium

SC 2 approves ARO of the Unicode Consortium in document SC 2 N 3841 and instructs its Secretariat to

submit it to JTC 1.

RESOLUTION M14-02: JTC 1 Ad hoc on Vocabulary

In response to the JTC 1 Ad hoc group expert on Vocabulary, SC 2 decides to extract and publish its vocabulary from its currently published standards on the SC 2/WG 2 website and invites its National Bodies to contribute the vocabulary terms used in their translated SC 2 standards. SC 2 suggests that the information be used by the ad hoc on IT Vocabulary. SC 2 appoints Mr. Alain LaBonté as its

representative to the JTC 1 Ad hoc group to monitor the project.
