1 Introduction

This is a proposal to encode a new character in the Universal Character Set: ढ DEVANAGARI LETTER MARWARI DDA. It is used in Devanagari orthography for Marwari (ISO-639: rwr) and other ‘Rajasthani’ languages for representing [d].

2 Character Details

Properties of the proposed character are as follows:

3 Background

In Devanagari, the phoneme [d] is represented using ढ U+0921 DEVANAGARI LETTER DDA. In Hindi and its allied languages, [d] has an allophonic variant [ɽ], which is written using ढ U+095C DEVANAGARI LETTER DDDHA. This letter is produced by writing ढ with ॠ NUKTA.




Figure 2: Line written in Marwari style of Devanagari (from Grierson 1908: 63). The highlighted word is ढावडा [ḍa:vṛa:] ‘sons’.

Historically, in Devanagari orthography for Marwari in Rajasthan, [d] is represented by the letter ढ and its allophone [ɽ] is written using ढ. The use of ढ is shown in Figure 1 and is attested in written documents, excerpts of which are shown in Figure 2 and Figure 3. Apparently, the character was also used in printed Marwari, at least in the early 20th century. In print, however, ढ was often replaced with Devanagari म MA when a metal punch for the letter was unavailable.¹

Information about the origins of the character is unavailable. But, based upon graphical typology, it is highly plausible that the character is derived ultimately from ढ U+1119D SHARADA LETTER DDA. It probably entered into Devanagari through Landa scripts used in Rajasthan. The Landa scripts are related to Sharada and use some variant of the form ‘𑂣’ for writing [d], eg. 𑂣 U+0A21 GURMUKHI LETTER DDA. This character also corresponds to 𑂣 U+11696 TAKRI LETTER DDA.

An independent encoding for ढ is required in order to represent the letter in plain text. While it is used for writing [d], the same sound represented by ढ DDA, it cannot be treated as a glyphic variant of DDA. Both letters are required to represent historical Marwari text in Devanagari.

4 Implementation Details

4.1 Name

The proposed character is assigned the name DEVANAGARI LETTER MARWARI DDA. This name seems more appropriate than other possible candidates, eg. DDDDA, etc.

4.2 Glyph Shape

The proposed glyph shape ढ is based upon the form given in Grierson (see Figure 1). The slightly different shape ढ is shown in Figure 3.

4.3 Collation

The proposed character should be sorted before ढ U+0921 DEVANAGARI LETTER DDA.

In writing Mārwarī the letters *ḍ* and *ṛ* are distinguished. This is not done as in Hindī by representing *ṛ* by the sign for *ḍ* with a dot placed under it, thus ढ. In Mārwarī there are two distinct characters, viz., ढ for *ḍ* and ड for *ṛ*. In printed Mārwarī, when the type for ढ is not available, the Dēvanāgarī letter ढ is often substituted for it, which is very inconvenient; as, in that case, for instance, only the context can tell whether बढो represents ‘baḍō’ or ‘bamō.’ In printing the Mārwarī specimens in the Dēvanāgarī character, I shall represent *ḍ* by ड and *ṛ* by ढ.
