Resolutions text

Resolution 2011.43: Symbol registrations for 9995-7 "Information technology -- Keyboard layouts for text and office systems -- Part 7: Symbols used to represent functions" and 9995-10 "Information technology -- Keyboard layouts for text and office systems -- Part 10: Conventional symbols and methods to represent graphic characters not uniquely recognizable by their glyph on a keyboard and in documentation" (WG 1)

ISO/IEC JTC 1/SC 35 requests Mr Karl Pentzlin, Mr Alain LaBonté and Prof Em Hiroaki Ikeda to take the appropriate steps to synchronize IEC 60417 and 9995-7 and 9995-10 descriptions, so that the ballots can be initiated in a timely fashion. Steps:

- Comment IEC TC 3/SC3C comments on 9995-7 symbols, and send them to Prof Em Hiroaki Ikeda.
- Initiate 9995-7 DAM ballot as soon as IEC TC 3/SC3C publishes relevant graphical symbols in IEC 60417 (expected end of 2011-10).
- Fix the descriptions of 9995-10 symbols in collaboration with Prof Em Hiroaki Ikeda before end of 2011-11.

ISO/IEC JTC 1/SC 35 notes that FDIS 11581-40 "Information Technology — User interface icons — Part 40: Management of icon registration" was unanimously approved. ISO/IEC JTC 1/SC 35 requests its secretariat to issue a call for nomination of delegates to a Validation Team in accordance with ISO/IEC 11581-40.

Resolution 2011.55: Appointment of Project Editors for project 17549 "4-Direction Devices" (WG 4 in cooperation with WG 1)

ISO/IEC JTC 1/SC 35 notes that the NP on 4-Direction Devices was approved as project 17549 and appoints Prof Em Hiroaki Ikeda as Project Editor and Mr Song Jaeil as co-editor. The project was allocated under WG 4 and will be addressed in common work with WG 1.

Resolution 2011.73: Definition of "accessibility" (WG 6)

ISO/IEC JTC 1/SC 35 strongly supports the existing definition of accessibility, as specified in ISO 9241-20:2007 and ISO 9241-171:2007. This definition is the basis for the standards of SC 35, including ISO/IEC 24756 and ISO/IEC 29136. ISO/IEC JTC 1/SC 35 resolves to continue to use this definition.

ISO/IEC JTC 1/SC 35 resolves that if (for whatever reason) a definition of accessibility is required that is not based upon usability, it should read as follows:

extent to which products, systems, services, environments and facilities can be used by people from populations with the widest range of user needs for the widest range of goals in the widest range of contexts of use

NOTE 1: Contexts of use include direct use or use supported by assistive technologies.

NOTE 2: While it is valid to claim compliance with accessibility standards, it is not appropriate to claim that something is accessible without specifying the user needs, goals, and contexts of use for which it is accessible.
