1 Introduction

This is a proposal to encode two new characters in the Sharada block of the Universal Character Set (ISO/IEC 10646). Properties of the proposed characters are:



These characters were identified in the original proposal to encode Sharada (N3595 L2/09-074R2: 8), but they were not included in the proposed repertoire on account of insufficient details regarding their usage.

2 Description

2.1 ≈ SHARADA SECTION MARK-1

This mark is used for indicating the end of a text section:



The below illustrates repeated usage of the mark:



2.2 ♠ SHARADA SECTION MARK-2

This mark is used for indicating the end of a text section. The excerpt below shows serial usage of the mark:



Below, the end of section is indicated using an alternating pattern of ≈ SHARADA SECTION MARK-1 and ♠ SHARADA SECTION MARK-2:
