
Introduction

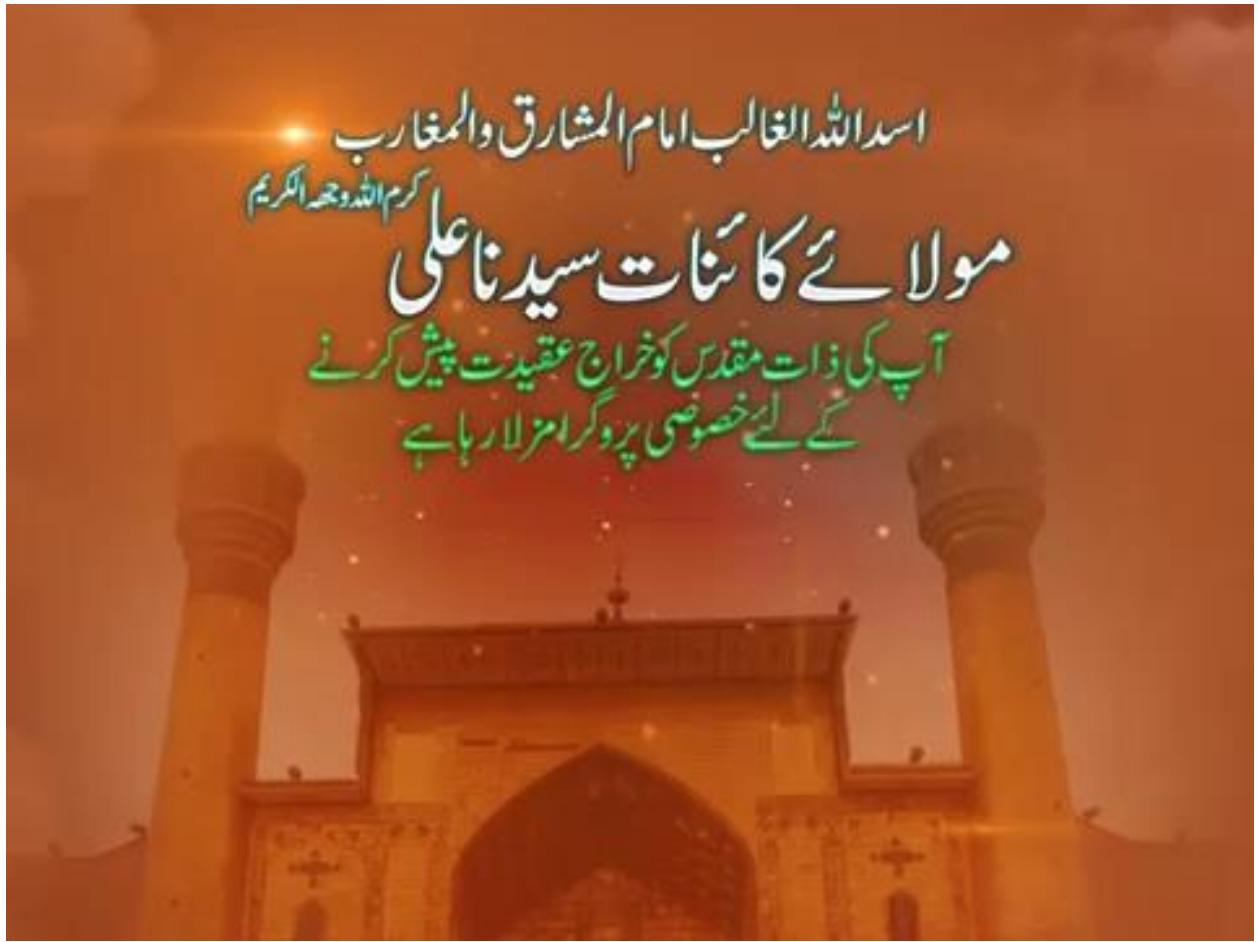
