1. Introduction

This is a proposal to encode one Bopomofo letter.

Mandarin Chinese has a few characters that are pronounced as a syllabic nasal, *m*, *n*, or *ng*. In the PRC (e.g. in *Xiàndài Hànyǔ Cídiǎn* 现代汉语词典 [Contemporary Chinese Dictionary]) these syllabic nasals are represented using U+3107 BOPOMOFO LETTER M ㄇ, U+310B BOPOMOFO LETTER N ㄢ, and U+312B BOPOMOFO LETTER NG ㄣ.

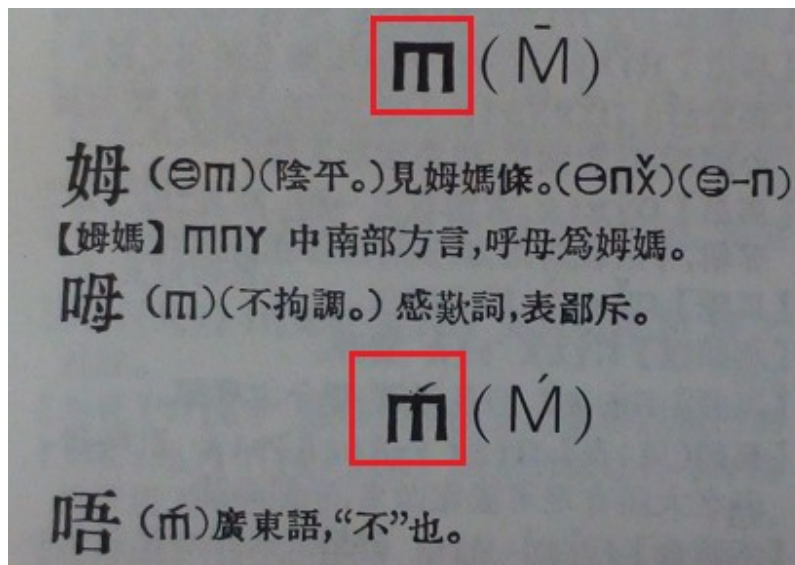


Fig. 3: *Guóyǔ cídiǎn* 國語辭典 p. 417 (U+31AC ㄇ and U+31AD ㄨ)

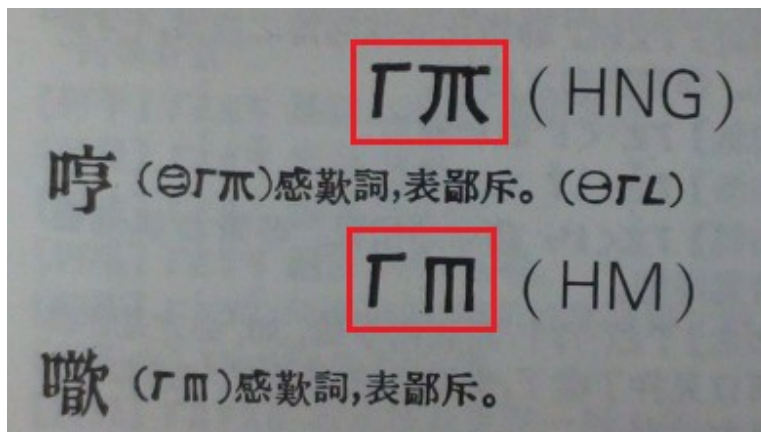


Fig. 4: <https://zh.wikipedia.org/wiki/注音符號> (2016-02-05)

However, in early sources, notably the 1937 *Guóyǔ cídiǎn* 國語辭典 [Dictionary of the National Language], and in some Taiwan books, the syllabic nasals are represented by a set of special Bopomofo letters derived from the Bopomofo letters M, N, and NG, but with a vertical stroke in the middle (see Fig. 1, Fig. 2, and Fig. 3). The syllabic letters M and NG with a vertical stroke are already encoded as U+31AC BOPOMOFO LETTER IM ㄇ and U+31AD BOPOMOFO LETTER NGG ㄣ. However, the corresponding syllabic letter N, derived from U+310B BOPOMOFO LETTER N with a vertical stroke in the middle, is not currently encoded. This is problematic, as explained in the Chinese Wikipedia article on Bopomofo (see Fig. 4).

Fig. 1 shows the unencoded Bopomofo letter NN with an attached falling tone mark. This mark is not part of the character.

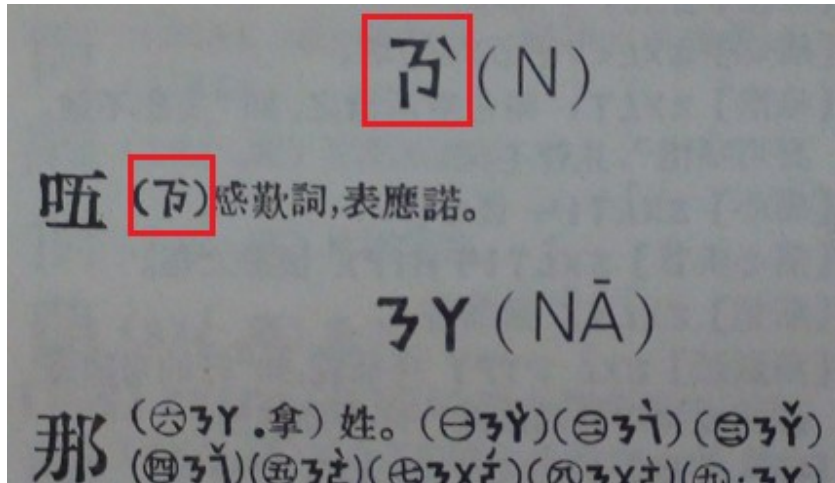
2. Unicode Properties

1932年教育部在「編定《國音常用字彙》特組會議」時決定，為了便利說明，添補一個注音符號「ㄇ」（ㄇ），作為「ㄅㄆㄇㄏㄏㄨㄩㄩㄩㄩ」七個聲母單獨成音節時的省略韻母（即虛母）。另外有三個注音符號ㄨ（-ng）、ㄨ（-m）、乃（-n），用作解釋聲隨韻母（ㄅ、ㄆ、ㄇ、ㄏ、ㄏ、ㄨ、ㄨ、ㄨ、ㄨ）時使用，（-n）的字形是ㄇ多加一筆直豎，尤解作Y+ㄨ、ㄨ解成ㄉ+ㄨ、ㄇ為Y+（-n）、ㄆ為ㄉ+（-n）；同理，複韻母ㄨ解為Y+ㄨ、ㄨ為Y+ㄨ。ㄨ、ㄨ、（-n）絕少單獨使用，「噉」常唸作「ㄉ」，也有人唸成「ㄨ（-n）」。

但以上符號只作為發音輔助說明用 未列入正式符號表中。

1986年，中華民國教育部公佈羅馬字拼寫的「注音符號第二式」，注音符號因此又稱為「第一式」。

使用現況 [编辑]

在臺灣，小學生學習漢字前，必須上十週的注音符號教學課，也有不少幼稚園亦已教授。日常生活中，注音符號既用來標注生僻字，亦是常用的漢字輸入法，其推廣相當普遍，多數電腦使用者均熟練使用。

在臺灣話、客家話的教學上，臺灣省國語推行委員會另外增添新符號以能拼讀這些「鄉土語言」，稱之為「臺語方音符號」，比如臺灣話音節的ㄨ、ㄨ，被正式訂為臺語方音符號，載入Unicode注音符號擴展區用字，（-n）則沒有收入，故無法顯示。

在中國大陸及港澳，學校不教注音符號，但是一些字典、詞典都通過漢語拼音與注音符號並列使用的方式給字詞注音，如《*新华字典*》、《*现代汉语词典*》等。
