

Proposal to Encode Additional Wasla Characters for the Holy Quran

Introduction

The standard printed Quran (Madina Mushaf) has only one character for a wasla.



Depending on its position or a character before it or if a user starts reciting after a pause, the same wasla character can be read differently: with a fatha, or a kasra, or a damma. For a person who doesn't know Arabic, it's not possible to know the exact sound that wasla represents. If we consider most Muslims don't speak Arabic and many of them read the Quran without Arabic knowledge, more than 1 billion people might be reading those words wrong.

Proposed Characters

I propose to leave U+0671 (Arabic Letter Alef Wasla) character for words with an original fatha, like:

الله الْكِتَابُ الَّذِي

and add two new characters to represent words that begin with an original damma or an original kasra like:

أَدْخُلُوهَا أَرْجِعِي

That will clear the confusion and help people recite the Holy Quran correctly.

I tried to create the shapes as familiar as possible, so users accepted them easily and didn't make them uncomfortable. For a wasla with an original damma, I chose a wasla with dot in front of it. A dot in front of a character historically used to denote a damma. For a wasla with an original kasra, I changed the position of the wasla symbol. Placing a symbol like a dot under a letter used to denote a kasra before the introduction of contemporary kasra symbol.
