Introduction


Balti language is spoken in Pakistan's Gilgit-Baltistan region and is written in Arabic and Tibetan/Yugi scripts. Khowar Academy is a nonprofit organization working on standardizing alphabets of Balti and other languages spoken in the region.

There is one alphabet in this language's Arabic script which are currently not supported in Unicode. In this proposal I want to present this character to Unicode teams for its inclusion.
