Editorial comment:

Page 1: In the entry for page 11 the new block name should be inserted after Runic (Amd.19), not after Ogham as shown.

Page 4: In the entry for page 703 (Annex B) the new character names should be inserted after 0FB9 TIBETAN SUBJOINED LETTER KSSA (see Amd.6), not after 0ECD LAO NIGGAHITA.
