# Resolution IRG M41.2: CJK Extension E Project (IRGN1957, IRGN1974 and IRGN1977)

**Unanimous** 

The IRG accepts the error report in IRG N1957. The ISO/IEC 10646 project editor has produced IRG N1977 as a new draft of CJK Extension E code table based on the feedback from IRG. The IRG member bodies are encouraged to review IRGN1977 and are requested to send any feedback to the project editor by the end of January, 2014.

## Resolution IRG M41.3: CJK Extension F Project (IRGN1945 and its feedback, IRGN1921 and its feedback, and IRGN1973)

**Unanimous** 

The IRG accepts the Ext F Editorial Report (IRGN1973). The IRG agreed to follow the review schedule as shown below:

- 2014-01-10: ROK to submit supplementary evidence for delayed Korean characters (IRGN1978).
- 2014-01-10: IRG members' chief editors to submit updated fonts, if necessary.
- 2014-01-17: IRG members' chief editors to submit a character-by-character ballot based on IRGN1978.
- 2014-01-31: IRG Chief Editor to produce CJK\_F1 v2.0 (IRGN1979).
- 2014-03-07: IRG members' chief editors to submit comments on CJK\_F1 v2.0.
- 2014-03-21: IRG Chief Editor to produce draft consolidated comments.
- 2014-03-28: IRG members' chief editors to submit feedback on the draft consolidated comments.
- 2014-04-04: IRG Chief Editor to produce confirmed consolidated comments.
- 2014-05-02: IRG members' chief editors to respond to comments related to their own submissions.

### Resolution IRG M41.4: IRG Principles and Procedures Revision (IRGN1952 and its feedback, IRGN1975)

**Unanimous** 

The IRG has reviewed all feedback on IRG PnP Version 6 draft 4 from HKSAR, Japan, TCA, and ROK. The IRG resolves to finalize Version 6 as IRGN1975 with reconfirmation of the published year of source information listed in Annex D by all member bodies. Any further revision will be reflected in future versions.

# Resolution IRG M41.5: Revision to IRG PnP regarding the document file size and sharing (IRGN1966)

Unanimous

The IRG accepts IRG N1966 in principle and instructs PnP editor, Dr. Lu Qin, to seek technical solutions, and report progress at IRG#42.

Resolution IRG M41.6: UNC proposals (IRGN1936 and its feedback, IRGN1954, and IRGN1967)

Unanimous Action: Rapporteur

The IRG resolves to accept the UNC submission from China as described in IRG N1967, and further instructs its Rapporteur to forward this submission to SC2/WG2 for further processing. The IRG also reviewed UNC submissions from UTC as IRG N1936 and from UC Berkeley's Script Encoding Initiative (SEI) as IRG N1954, but could not reach a consensus due to questions related to urgency, stability, and technical issues.

### Resolution IRG M41.7: Request related to the note field in review comments (IRGN1969)

Unanimous

The IRG accepts IRG N1969 in principle. IRG member bodies are encouraged, in general, to make appropriate notes for all comments prior to submitting editorial review comments.

# Resolution IRG M41.8: IRG Working Document Series (UCV and NUC Lists) (IRGN1950 and its feedback, IRGN1974)

**Unanimous** 

The IRG reviewed feedback for IRGN1950 from HKSARG, Japan and ROK. The IRG instructs IWDS Editor to try to resolve technical issues in generating the charts as stated in the editorial report (IRGN1974). The IRG also encourages member bodies to submit to the IWDS Editor example characters by 2014-01-17. The target date for producing the revised tables is 2014-03-21.
