

**Title: ISO/IEC 10646 repertoire proposal post CDAM2.4**

## Executive Summary:

This document describes in some details the content of CDAM2.4 in comparing the repertoire that was adopted during WG2 #70, and the further refinements done to the repertoire and CJK Horizontal Extensions. The result of these considerations can be seen in the updated version WG2 N5246 at <https://www.unicode.org/wg2/docs/n5235R-cdam2-3-drafchart.pdf>.

### Amendment 2.4 repertoire

The document WG2 N5234 (WG2 #70 recommendations, dated 6-22-2023) made a set of recommendations defining the content for CDAM2.3 but left some latitude to refine the content based on additional feedback and further progress on some of the new repertoire. Document WG2 N5241 provided details and reference concerning the repertoire content of CDAM 2.3. Following comments made on CDAM2.3 and their disposition (see WG2 N5245), minor adjustments were made to the repertoire. This document presents only repertoire and glyph changes between CDAM 2.3 and CDAM 2.4.

### Updates made because of the disposition of comments on CDAM2.3:

The disposition introduces 10 new characters to the repertoire:

- 1 Khitan Small Script character as:
  - o 18CFF KHITAN SMALL SCRIPT-18CFF,
- 7 pictographs as:
  - o 1FA89 HARP
  - o 1FA8F SHOVEL
  - o 1FABE LEAFLESS TREE
  - o 1FAC6 FINGERPRINT
  - o 1FADC ROOT VEGETABLE
  - o 1FADF SPLATTER
  - o 1FAE9 FACE WITH BAGS UNDER EYES
- 2 CJK Stroke characters as:
  - o 31E4 CJK STROKE HZXG
  - o 31E5 CJK STROKE SZP

These new characters are described in the following table which includes all the proposed new ranges with pointers to the relevant documentations:

The disposition also modifies the glyph of 4 Tangut characters (U+17121, U+17C51, U+17D0B, U+180DF), one Khitan Small Script character (U+18BD2) and one K source horizontal extension (U+25A38, K source: K6-110D).

It also adds 8 standardized variation sequences (see <https://www.unicode.org/L2/L2023/23212r-quotes-svs-proposal.pdf>) and moves two J sources JMJ references newly introduced in this amendment (see WG2 N5245):

- JMJ-034551 from U+21D12 to U+21D14
- JMJ-055848 from U+8FF3 to U+2EDE0 (in newly proposed CJK Unified Ideograph Extension I).

#### **Updates made to stay synchronized with Unicode 16.0 (planned for 2024):**

One character was added to the Egyptian Hieroglyphs extension after further feedback from Egyptologists (inserted at U+143E8 with following characters shifted accordingly). To keep the synchronization with Unicode 16.0 the following 3 Latin characters are also added:

- A7DA LATIN CAPITAL LETTER LAMBDA
- A7DB LATIN SMALL LETTER LAMBDA
- A7DC LATIN CAPITAL LETTER LAMBDA WITH STROKE

These new characters are described in the following table which includes all the proposed new ranges with pointers to the relevant documentations:

This makes a total of 14 code points addition compared to CDAM 2.3.

#### **Source references for Egyptian Hieroglyphs**

In CDAM2.3 the source references for Egyptian Hieroglyphs were documented in new text (clause 27) and corresponding text file: Hieroglyphsources.txt. Unicode 16.0 is introducing a new Draft Unicode Standard Annex: UAX #57: Unicode Egyptian Hieroglyph Database <https://www.unicode.org/reports/tr57/> which includes the same content in more details. It is preferable to simply link to it as a normative reference to avoid duplication of effort and to improve synchronization between Unicode and ISO/IEC 10646.
