# Comments

We support the spirit of this resolution. But the wording must be clearer in order to prevent procedural problems in the future. The resolution asks only for a statement from TC46/SC4 without stating how this will be prepared. The most obvious way is that by letter ballot. This will coincide with a letter ballot in JTC1/SC2. But a vote is meant to express the position of a single NB, without respect to SC membership. Thus disagreements on a vote should be solved at the national level first.

Our no-vote will be turned into yes, if proper changes will be made in the wording of the resolution taking our comments into account.
