We need to be able to produce the format in a variety of commercially available tools. XHTML would be our recommendation. Most of the web authoring tools lets you produce XHTML. No "undue burden" through complex dot-styles. Simple set of styles is needed.

XML is good for data tables – as soon as the tools are available.

We want to review any suggested formats.
