Resolutions of ISO/IEC JTC 1/SC 2 Plenary Meeting, Tokyo, Japan, 2009-10-30

National bodies and Liaison organizations present at this plenary:

RESOLUTION M16.01: Endorsement of Chairman

SC 2 endorses Dr. Yoshiki Mikami as its new chairman for a three-year term. SC 2 Secretariat is instructed to forward this nomination to JTC 1 for approval.

RESOLUTION M16.02: Appreciation to Mr. Tatsuo L. Kobayashi

SC 2 extends its appreciation to its retiring Chairman, Mr. Tatsuo L. Kobayashi, for his leadership over the past six years. SC 2 recognizes that he made JTC 1 aware of the social responsibility of technology by introducing the SC 2's activities on minority languages at the JTC 1 plenary meetings.

RESOLUTION M16-03: Continuation of OWG-SORT

SC 2 approves the continuation of OWG-SORT for the maintenance of ISO/IEC 14651 until the next SC 2 plenary with the following terms of reference:

- incorporate the following changes in the latest edition of ISO/IEC 14651:
 - a new Common Template Table (CTT) for sorting additional characters corresponding to the planned revised edition (including amendments 5, 6, 7 and 8) to the current edition of ISO/IEC 10646 (corresponding to Unicode standard 6.0)
 - corrections to the CTT to fix potential problems discovered since the latest official publications if evidence to that effect is found by national member bodies [US already has received fixes required for Malayalam and Tamil].

SC 2 re-appoints Mr. Alain LaBonté as the Convener of OWG-SORT.

RESOLUTION M16.04: Progression of Project for Amendment 2 to ISO/IEC 14651:2007

SC 2 approves that the project for Amendment 2 to ISO/IEC 14651: 2007 is progressed to PDAM. SC 2 instructs its Secretariat to initiate a 3-month PDAM ballot when the confirmed texts and tables (English and French) are submitted by the project editor.

SC 2 notes that the target dates of this project are: PDAM: 2009-11-30, FPDAM: 2010-04.

RESOLUTION M16.05: New Edition of ISO/IEC 14651

SC 2 creates a subproject for a new edition of ISO/IEC 14651 which consolidates ISO/IEC 14651: 2007, its Amendment 1 and Amendment 2. SC 2 approves that FDIS ballot is initiated instead of FDAM 2 ballot, on the condition that the FPDAM has passed its ballot successfully according to the JTC 1 Directives clause 15.1.6.

RESOLUTION M16.06: Letter to ISO DEVCO Members

SC 2 approves the letter to DEVCO members in SC 2 N 4109 (WG 2 N 3724) and instructs its Secretariat to forward it to ISO Central Secretariat for circulation to the DEVCO members. Further, SC 2 appoints Dr. Debbie Anderson as its representative to ISO DEVCO.

RESOLUTION M16.07: Letter to SC 6 regarding the Revision of ISO/IEC 10646 which includes ASN.1 related specification

SC 2 approves document SC 2 N 4108 (WG 2 N 3732) addressed to JTC 1/SC 6 and instructs its Secretariat to forward it SC 6.

RESOLUTION M16.08: Progression of Project for Amendment 7 to ISO/IEC 10646: 2003

SC 2 approves that the project for Amendment 7 to ISO/IEC 10646: 2003 is progressed to FDAM. SC 2 instructs its Secretariat to submit an FDAM text to be prepared by the project editor to ITTF for a two-month ballot.

RESOLUTION M16.09: Progression of Project for Amendment 8 to ISO/IEC 10646: 2003

SC 2 approves that the project for Amendment 8 to ISO/IEC 10646: 2003 is progressed to FPDAM. SC 2 instructs its Secretariat to initiate a four-month ballot when the text is submitted by the project editor.

SC 2 instructs the project editor of ISO/IEC 10646 to include Amendment 8 in the FCD of the new edition.

RESOLUTION M16.11: Change in the title of the new edition of ISO/IEC 10646

SC 2 endorses the change in the title of ISO/IEC 10646 to:

"Information technology – Universal Coded Character Set (UCS)"

removing the words "multiple-octet" from the title of the current edition. SC 2 instructs its Secretariat to report this change to JTC 1 and ITTF.

RESOLUTION M16.12: Progression of Project for new edition of ISO/IEC 10646

SC 2 approves that the project for the second edition of ISO/IEC 10646 is progressed to FCD. SC 2 instructs its Secretariat to initiate a four-month ballot when the text is submitted by the project editor. SC 2 notes that the new edition includes Amendment 1 to 8 to ISO/IEC 10646: 2003.
