This is a summary to IRG Meeting #33 Resolutions(IRGN1630) as listed in WG2 N3741.

1. Future Meetings(for endorsement): Resolution IRG 33.1

The following gives the IRG future meeting schedules:

IRG#35	Macao SAR, 2010-11-8~12 (Pending approval)
IRG#36	Kuala Lumpur, Malaysia, late May/June 2011 (tentative)

- 2. Provision of evidence for all submissions(for information): Resolution IRG M33.2 All character submissions must be accompanied by evidence with no exceptions.
- **3.** Macao Supplementary Character Set Submission(for information): Resolution: IRG 33.3 Deadline is set to May 14, 2010 for submission of evidence of Macao characters for inclusion in Ext. E.

4. CJK Extension E Work(for information): Resolution IRG 33.4

CJK Ext. E review work is postponed due to the urgency of CJK multi-column review. Evidence submission for CJK Ext E for all IRG members is set to June 4, 2010 and the Ext. E collection will be frozen in IRG Meeting No. 34.

5. Old Hanzi Encoding(for information): Resolution IRG 33.5

Old Hanzi Group will be submitting a consolidated list (Version 2) for IRG review at IRG Meeting No. 34. Further plan of work is to have two rounds of offline reviews to produce Version 4 before IRG Meeting No. 35 for possible submission to WG2 after IRG Meeting No. 35.

6. CJK Multi-column Code Chart Review (for review and discussion): Resolution IRG 33.6 In consideration of the manpower, time, and quality of result, IRG concluded that it is not possible to give a quality review to CJK Extension B in a 6 month period, thus instructs the IRG Rapporteur to make recommendation to WG2 to use the old code chart for CJK Extension B for the 2nd edition. Member bodies are requested to submit their list of mapping changes to IRG Rapporteur by 2010-04-05.

Review of BMP will be conducted in two rounds in two subgroups (division of work and independent review) to ensure quality review to produce consolidated review report by June 4, 2010.

7. Development of IRG Principles and Procedures(P&P) and the IRG Working Document Series(IWDS)(For review and discussion): Resolution IRG33.7

IRG is to produce its P&P Version 5(WG2N3744) and its IWDS Version 4(WG23746) for feedback in this WG2 meeting.

8. Japan Submission to IVD (for information): Resolution IRG 33.8

For the IVD submission planned by Japan, IRG would also like to review the document for review as the content might have implication to future IRG work.

- **9. ROK Mapping Issue** (**for information**): **Resolution IRG 33.9** IRG agrees with ROK's proposed solution to the ROK mapping issue (WG2N3747).
- **10.** Annex S Revision(for review and discussion): Resolution IRG 33.10
