Introduction

We wish to propose the addition of LISU LETTER YHA in the "Lisu (Lisu)" script. The current Lisu block (U+A4D0)..U+A4FF) does not have any more room for another character. Thus, a new column will need to be added to the Lisu block. Since the script is not casing, it should be acceptable to encode the new block in the SMP at the recommended position of U+11FA0. This will require one column for the Lisu script at U+11FA0..U+11FAF.

The character follows the properties of similar characters as described in "Character Name and annotations".

The Naxi [nxq] language of China is spoken by 300,000 [Ethnologue]. The Naxi language is primarily written using the Latin script. However, it was written (perhaps experimentally) in the 1920s and 1930s using the Fraser i.e. Lisu script [Ethnologue]. Recent efforts to digitize the historical documents have made it necessary to encode this character. In reviewing the original Unicode proposals for Lisu, this character does not appear to have ever been proposed.

In the "Figures" section we have examples from three different documents showing the use of this character. There are 360 instances of LISU LETTER YHA in the Gospel of Mark and 1,062 instances of the "LISU LETTER YA" in the Gospel of Mark. This shows that it is not quite as commonly used as YA but it is also not uncommon. The shapes for the two characters:

YA: Υ YHA: ⅄

This character looks like U+2144 TURNED SANS-SERIF CAPITAL Y (with Sm property). However, for the same reasons that the Lisu script was encoded, this character should be encoded in a Lisu script block with similar properties to other Lisu characters.

Thus, we wish to request the encoding of LISU LETTER YHA with properties as described below.
