To Whom It May Concern,

On Thursday, 21 Sha'ban 1446 AH (February 20, 2025 CE), the Custodian of the Two Holy Mosques, King Salman bin Abdulaziz Al Saud, approved the official Saudi Riyal symbol, marking a historic milestone in strengthening the national currency's identity. This symbol has been designated as the official representation of the Saudi Riyal for use in financial, commercial, and digital transactions.

In line with Saudi Arabia's Vision 2030, which prioritizes financial modernization and digital transformation, we respectfully submit a formal request for the Unicode Consortium to register the Saudi Riyal symbol in the Currency Symbols block of the Unicode Standard. The enclosed proposal document outlines the official design, technical specifications, and supporting evidence of its adoption across various financial and economic sectors.

Introduction

On February 20, 2025, the Custodian of the Two Holy Mosques, King Salman bin Abdulaziz Al Saud, approved the creation of the Saudi riyal symbol for representation of the Saudi riyal currency in text. This symbol was designed in collaboration between the Saudi Arabian Central Bank; the Ministry of Culture; the Ministry of Media; and the Saudi Standards, Metrology and Quality Organization. The new symbol was announced on February 20, 2025 and recommended for immediate usage in finance and commerce.

Custodian of Two Holy Mosques Approves Saudi Riyal Symbol

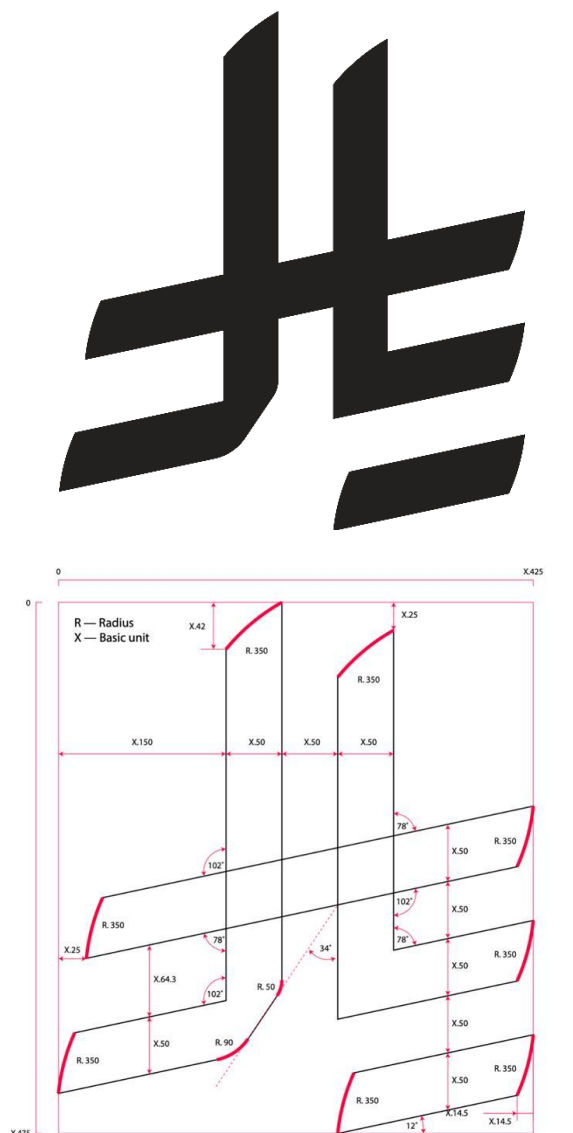
To facilitate use of the new symbol and support in software products, online services and devices, the Saudi Central Bank proposes that this character be encoded in Unicode and in ISO/IEC 10646 at the earliest opportunity.

Proposed character code point and name: U+20C1 SAUDI RIYAL SIGN

Usage Rules

1- Position:
The symbol should be positioned to the left of the numeral.



2- Spacing:
A space is required between the symbol and the numeral.



3- Proportions:
The shape of the symbol should be maintained.



4- Geometry:
The geometric structure of the symbol should be maintained.



5- Alignment:
The height of the symbol should be aligned with the height of the text.



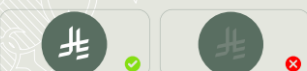
6- Direction:
The direction of the symbol should match the direction of the text.



7- Integration:
A clear space equal to one-third of the symbol's height is required around the shapes.



8- Contrast:
Sufficient color contrast with the background is required.
