The Ideographic Rapporteur Group of JTC 1/SC 2/WG 2 will hold its first meeting in Fukuoka, Japan. It will be hosted by Information Technology Standards Commission of Japan (ITSCJ).

The invitees to this first meeting are the previous attendees of CJK-JRG or their substitutes per the mailing list provided to me by Mr. Shigenobu KATO, the Standing Secretary for CJK-JRG. The IRG was created as an official ISO arm of WG 2 of JTC 1/SC 2 based on a proposal submitted by Japan at the last meeting of WG2 and the plenary meeting of SC2 held in Athens, Greece in May 1993. The proposal to create the IRG was approved at that plenary session of SC2. WG 2 document N 902-R contains the proposal for the creation of the IRG. Document SC2 N 2462 is the corresponding SC2 document, Resolution 3 in document SC2 N 2466 states that JTC 1/SC 2 "endorses the formation of the Ideographic Rapporteur Group (IRG)". Copies of documents SC2 N 2462 (WG 2 N 902R) and N 2466 are attached. They are numbered WG2/IRG N 2 and WG2/IRG N 3 respectively.

The contact person for this first meeting and the logistics coordination is Mr. Shigenobu KATO of Toppan Printing Co. Ltd. Mr. Kato will contact the participants of earlier CJK-JRG meetings directly regarding hotel reservations and accommodations. I will provide meeting details as soon as I receive them from Mr. Kato.
