1. Request for approval of future IRG meetings

IRG #24: Taipei/Nantou, Taiwan (TCA), 2005-05-23 ~ 27. Japan as backup (After Meeting

IRG #25: Bay Area, USA (Unicode Consortium), 2005-12-12 ~ 16 (tentative)

IRG #26: Taiwan (TCA) or Japan depending on the place of IRG Meeting #24, China as backup

IRG #27: Hong Kong SAR (pending approval from HKSARG)

2. **Request for approval** for the postponement of Ext. C1 work

In order to ensure quality of C1 work, the IRG has resolved to postpone the project completion work by one year targeting at the end of 2005. The IRG will adopt the Ideographic Description Sequence for its editorial work.

3. **Submission** of IICore collection (IRG N1095).

The IRG has requested the Rapporteur to submit the IICore collection to WG2 and the project editor for inclusion in Amendment 1 to ISO/IEC 10646: 2003.

The IRG agrees to maintain the supplementary classification of source identifiers submitted by member bodies.

4. Follow up action requested by WG2 Meeting 45(Markham)

Under the request of WG2 Meeting 45 on assessment for the Provision of CJK Ideographs source visual reference information (WG2 Resolution M45.33), the member bodies need more time to do assessment on their individual contribution. The IRG requests member bodies to assess the possibility and time schedule for providing source visual reference information for Extension B characters before IRG Meeting #24.

5. Work in progress on Old Hanzi and CJK Strokes

An Old Hanzi Expert Group is formed within the IRG. The IRG accepts that each type of Old Hanzi should be considered and classified as a separate script in its own right. A preliminary work schedule was drafted and member bodies will be submitting sample scripts for further study at the next IRG.

A CJK Strokes Ad Hoc Group was formed with proposed work plan. Member bodies are to review member contributions and requested to send comments on the encoding model and stroke repertoire for discussion at IRG Meeting #24.
